Course Provisions: Lee Driving School, Inc. will provide a minimum of 24 hours of classroom instruction (one 2-hour absence is permitted), 6 hours of behind-the-wheel (BTW) instruction, and 4 hours of observation time in a dual-controlled automobile (fully insured, covering each student enrolled in the program). Classroom instruction must be a minimum of 3 weeks in length. A score of 70% or higher on all quizzes and the State of Michigan written test (up to two retakes are allowed) is required. To accommodate missed classes due to illness or other excused absences, students will arrange time during an upcoming Segment 1 class. BTW instruction shall not begin until the student has received a minimum of 4 hours of classroom instruction. BTW instruction must be completed no later than 3 weeks after the classroom instruction has been completed. (Note: A statement form signed by the parent or guardian granting approval for individualized behind-the-wheel instruction must be submitted before any student is allowed to ride alone with a driver education instructor. The statement form (Segment 1 Registration Form) will be sent home with each student, completed and returned.)

Terms of Payment and Refund Policy: The course fee is \$320.00--payable by check, money order or cash. (When gas prices exceed \$4.00 per gallon, we reserve the right to add a \$10.00 surcharge.) **Returning the contract with a \$100.00 deposit (payable to Lee Driving School, Inc.) enrolls the student--unless the class is filled.** The balance of the course fee is due the first day of class (balance will be \$220.00). Before the third class session, 80% of the course fee will be refunded. No refund will be given after that. No refund will be given after road instruction has begun.
