Before a student can be accepted into Segment 2, a minimum of 30 hours of supervised driving (including two hours of nighttime driving, on a Level 1 License that has been held for at least three continuous months) must be completed. Supervised driving is defined as driving with a licensed parent, guardian or parent designee aged 21 or older. **Proof of a valid Level 1 License will be required on the first day of class.**


Course Provisions: Lee Driving School, Inc. will provide a minimum of 6 hours of classroom instruction provided by a certified instructor. Classroom instruction shall not exceed 2 hours per day. A score of 70% or higher on the State of Michigan written test is required (up to two retakes allowed). To accommodate a missed class due to illness or other excused absence, students will arrange time during an upcoming Segment 2 class.

Terms of Payment & Refund Policy: The parent/guardian agrees to pay the course fee of \$50.00. (The course fee is payable by check, money order or cash.) This fee covers the required class time, use of a textbook and all necessary materials.

Please register by sending \$50.00 with this form--making check payable to Lee Driving School, Inc. (Refer to upper left or right.) **Personal checks WILL NOT be accepted on the first day of class.** A full refund will be provided if notice of cancellation is given seven days prior to the beginning of the Segment 2 class for which the student is registered.
